## SAVE OUR SCHOOLS

Saving Pacifica Schools, a newly formed political action committee (PAC), is running an online petition to secure TARP funds for reimbursement of monies lost in the collapse of Lehman Brothers. The Pacifica School District (PSD) was required by law to deposit money in the county treasury, which invested the money in Lehman Brothers bonds. When Lehman Brothers went bankrupt, PSD lost \$700,000. On May 21, Congressman Barney Frank is holding hearings on disbursing TARP funds to public entities that have been financially damaged. ## VEGGIE DAY

The Belgian city of Ghent is about to become the first in the world to go vegetarian at least once a week. Ghent means to recognize the impact of livestock on the environment. The UN says livestock is responsible for nearly one-fifth of global greenhouse

gas emissions, hence Ghent's declaration of a weekly "veggie day." Public officials and politicians will be the first to give up meat for a day. Schoolchildren will follow suit with their own "veggiedag" in September. It is hoped the move will cut Ghent's environmental footprint and help tackle obesity. Around 90,000 so-called "veggie street maps" are now being printed to help people find the city's vegetarian eateries. (Chris Mason, BBC News)

## COUNTY TOPS

Moody's Investors Service has affirmed San Mateo County's issuer rating of Aa1 as part of its annual ratings review. The Aa1 rating was initially assigned by Moody's last August when the County refinanced its Youth Services Center bonds. Moody's also assigned an Aa3 rating to the County's 2003 Maguire Jail bonds and affirmed the Aa3 rating assigned to the 2008 Youth Services Center refinancing as part of the review. With issuer ratings of Aa1 from Moody's and AAA from Standard and Poor's, San Mateo County continues to be the highest-rated county in the state. These high ratings are a reflection of the County's creditworthiness. This means that the County can borrow money (issue bonds) at lower interest rates, which saves taxpayer dollars. ## PET FOOD ALERT

The U.S. Food and Drug

Administration (FDA) has confirmed that the agency is investigating NUTRO pet food, following a series of unexplained illnesses and deaths. Consumers have been complaining for more than two years that their pets have become ill after eating NUTRO products; many have recovered when they were switched to other foods. The company has steadfastly denied that its food is to blame. Until now, the FDA has been mum about whether it was actively investigating the company. Today, the FDA's Division of Freedom of Information confirmed the agency has an ongoing investigation into NUTRO and said that investigation could be criminal or civil in nature. The office did not elaborate on the nature or focus of that investigation. The investigation came to light when the FDA denied a Freedom of Information Act (FOIA) request by ConsumerAffairs.com seeking a list of complaints and lab results the agency has collected regarding NUTRO pet food. The agency denied the request and said that releasing the information could hamper "prospective or ongoing" action by law enforcement. "The document(s) constitute record(s) compiled for law enforcement purposes, the disclosure of which could reasonably be expected to interfere with enforcement proceedings," wrote the FDA's George A. Strait, Jr., assistant commissioner for public affairs. (Lisa Wade McCormick, ConsumerAffairs.com, April 20)
